Self-attested photocopies of proof of date of birth (class 10th certificate/ school certificate), eligibility qualification leaving mark-sheets, degrees, experience certificate (if applicable), degree certificate, caste qualifying registration with statutory council (if applicable) and other relevant testimonials.

- **9. Short Listing:** Based on bio-data, the candidates may be short-listed for walk-in-interview.

## **TERMS & CONDITIONS**

- 1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience.
