3. **Age Concession:** Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects), and ex-servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of services rendered in the research projects will also be admissible for experienced and skilled persons. The last date of application would be used as the cut-off for calculation of age to consider eligibility and concession.

If written examination is done then multiple choice questions in the subjects of General Science, General Analytical ability and knowledge of concerned area will be asked.

5. The candidates shall report for appearing in the walk- in- exam and/or interview with the following:

Original certificates in support of his/her age (class 10th certificate/ school leaving certificate), educational/ professional qualification, experience, caste certificate (if applicable), qualifying degree registration with statutory council (if applicable) etc., two recent passport size colour photographs and a one set of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the walk-in-written test/interview.

### **TERMS & CONDITIONS**

**1.It is candidate's responsibility to ascertain and ensure the eligibility as per the prescribed qualification and experience. Candidates' applications will be screened on the day of written test/interview and if not found eligible for the post, he/she will not be allowed to appear for written test/interview. Even after qualifying the eligibility/selection process the candidate may be rendered disqualified at the time of document verification if documents are found incomplete/wrong information is given.**

2. These appointments will be made from the staff strength sanctioned to the extra-mural project and employment in this extra-mural project will not vest any right to candidate for appointment within the sanctioned staff strength of AIIMS Bhopal.

3. **Tenure:** The assignments are purely on contract basis for the period specified above. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Bhopal or for continued contractual appointment.

4. **Expiry of Contract:** The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.

5. **Leave:** The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy governing extramural / short term research projects as amended from time to time.

6. The candidate who is already in government service shall submit "No Objection Certificate" from the present employer at the time of walk-in-written test/interview.

7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.

8. No travelling or other allowances will be paid to the candidate for appearing in written examination/interview or for joining the post.
10. Canvassing of any kind will lead to disqualification.
11. Private practice of any type is prohibited.
12. He / She can be posted at any place in Singrauli district, Madhya-Pradesh or nearby place as per the requirement of the project including rural/urban areas/ field sites.
13. He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
