## **General / Minimum Qualifications And Instructions:**

- i. Good academic record as defined by the concerned University with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent Degree from an accredited Foreign University.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- iii. Candidates, who have been awarded a Ph. D. Degree in accordance with the *University Grants Commission (Minimum Standards and Procedure for Award of Ph. D. Degree) Regulations, 2009*, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.
- iv. NET/SLET/SET shall also not be required for such Masters Programmes in Disciplines for which NET/SLET/SET is not conducted.

### **Minimum Qualification for B.C.A. (Honors)**

- i. Should have 45% of the marks at the under-graduate level (with at good academic record)
- ii. Should have 55% marks at post-graduate level
- iii. Should have passed NET / SET in MCA / MSc (CS/IT). NET/SET is exempted to the candidate who have completed their M.Phil. Degree or have submitted their Ph.D. degree on/before 31/12/1993 and 31/12/2002 respectively.
- iv. Relaxation of 5% may be provided from 55% to 50% of the marks at Master's Degree Level and 45% to 40% at Under-Graduate Degree Level for SC/ST category & Physically Handicap candidates respectively.
- v. Relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. Degree Holders who have passed their Master's Degree prior to 19<sup>th</sup> September 1991.
- vi. NET/SLET/SET shall be exempted for the requirement of Assistant Professor / equivalent positions, who are or have been awarded a Ph.D. degree in accordance with UGC regulations 2009 (Minimum Standards & Procedures for award of Ph.D. degree)

1. First Class of Bachelor's or Master's Degree in appropriate branch of specialization in Pharmacy.
2. Registration as a pharmacist under the Pharmacy Act, 1948, as amended from time to time, including any succeeding enactments.

**ii. Desirable:**

1. Teaching, research, industrial and / or professional experience in a reputed organization; and
2. Papers presented at Conferences and / or in refereed journals.

### **Associate Professor**

**i. Essential:**

1. A basic degree in pharmacy (B. Pharm.)
2. Registration as a pharmacist under the Pharmacy Act, 1948, as amended from time to time, including any succeeding enactments.
3. A Ph.D. Degree with First Class at Bachelor's or Master's Degree in the appropriate branch of specialization in Pharmacy, and experience of eight years in teaching, research, industry and / or profession at the level of Lecturer or equivalent grade; excluding period spent on obtaining the research degree

OR

- ii.** In the event the candidate is from industry and the profession, the following shall constitute as essential:

1. First Class Master's Degree in the appropriate branch of specialization in Pharmacy;
2. Significant professional work which can be recognized as equivalent to a Ph.D. Degree in appropriate branch of specialization in Pharmacy and industrial / professional experience of eight years in a position equivalent to the level of Lecturer,

Provided that the recognition for significant professional shall be valid only if the same is recommended unanimously by a 3-Member Committee of Experts appointed by the Vice-Chancellor of the University.

**iii. Desirable**

1. Teaching, research, industrial and / or professional experience in a reputed organization;
2. Published work, such as research papers, patents filed / granted, books and / or technical reports; and
3. Experience of guiding the project work, dissertation of post graduate or research students or supervising R&D projects in industry.
