Office Order (Recruitment of Medical Lab. Technician)

The Punjab State AIDS Control Society (PSACS) invites **online applications (through mobile app only**) for filling up of vacant posts of Medical Lab. Technicians (MLTs) on Contractual Basis in Punjab State AIDS Control Society (PSACS) in Integrated Counseling and Testing Centres (ICTCs) and Anti-retroviral Therapy (ART) Centres under National AIDS Control Programme. The last date of submission of application is **28-11-2023**.

Number of vacancies: There are **13 vacancies (tentative)** to be filled strictly based on the reservation roster. Table 1 below provides the total and the category-wise number of vacancies. Candidates from other categories shall not be considered.

Step 2: Click on Register button, you will get an option to "Register For Examination"

Step 3: Select "Register for Examination" and click on Continue button to proceed.

Step 4: Now you have 3 Options, Enter Full Name, enter valid email id and enter your phone number, click on register button.

Step 5: Enter the OTP which you have received on your phone number. Click on Submit

Step 6: Select the examination you want to enroll for and click on continue.

Step 7: Please read the instruction and click on Next

Step 8: Follow the complete steps and enter the correct information.

Step 9: Click on to submit for registration, on the email ID you will get the admit card if the registration is approved.

<u>Candidates may please note that only applications received from mobile app registration will be</u> <u>entertained i.e. applications sent by email/post/in-person in the O/o PSACS will not be</u> <u>considered and so will be rejected.</u>

Salary: The MLTs shall be paid a consolidated salary of Rs.21,000/- per month.

The question paper will comprise of questions on:-

- 1.Basics of HIV
- **2.** HIV Testing
- **3.**CD4 testing
- 4. Viral load testing

Instructions for written test:-

- > The candidates should reach the venue one hour before the start of the exam.
- > The question paper will be in English and will be of objective type MCQs.
- > There will be no negative marking.
- > Candidates will be given 1:30 hours for the examination.
- > Candidates must bring one identity proof i.e. Aadhar Card/Voter Card with them.
- > Candidates will not be paid any TA/DA who will appear for written test.
- > The use of mobile phones or other electronic gadgets are strictly prohibited at the examination centre/venue.

Instructions for document verification (For candidates who will clear the written test):-

- The candidates are required to bring original documents/certificates comprising Academic certificates, experience certificates, Proof of passing Punjabi upto Matric standard or its equivalent standard from any recognized institution/Board or proof of passed the Punjabi Language Proficiency Test conducted by the Department of Languages, Government of Punjab, category certificate issued from Punjab Govt. (if claimed), Age proof and Photograph alongwith photocopy of all testimonials.
- > Additional time shall not be given to submit the certificates/testimonials.
- In case candidate fails to produce any certificate/testimonial or found fake/forged on the day of document verification, the eligibility would be cancelled with immediate effect.
- Candidates will not be paid any TA/DA for attending document verification.

Criteria to determine merit: Eligible candidates have to pass the written test (35% minimum passing marks) and the selection will be done purely on the merit of marks obtained in the written test.

- c. Interested candidates having the qualification mentioned against the post of Medical Lab. Technician (MLT) may apply through **mobile app only**.
- d. Only applications received from mobile app registration will be entertained i.e. **applications sent by email/post/in-person in the O/o PSACS will not be considered and so will be rejected**.
- e. The candidate should have passed Punjabi up to Matric standard or its equivalent standard from any recognized institution/Board or should have passed the Punjabi Language Proficiency Test conducted by the Department of Languages, Government of Punjab.
- f. Incomplete applications will be rejected.
- g. All particulars including category once filled by the candidates, could not be modified and no change shall be permitted at any stage of online application form. So, the candidates are advised to fill all their particulars after taking due care and precaution. PSACS shall not be responsible or liable in anyway.
- h. The number of posts is subject to **increase or decrease** as per the decision of the Project Director, PSACS.
- i. The certificate for reservation must be issued by the competent authority. The certificate must be latest one i.e. issued on or before the last date of submission of application form. No request for extension of submission of documents will be considered.
- j. These posts are purely **contractual and temporary for one year**, extendable based on work performance and conduct.
- k. Educational qualifications must be from a recognized University/Board. You should have all the requisite original certificates at the time of submission of the application. Additional time shall not be given to submit the certificates/documents.
- 1. If a candidate is found not to be fulfilling the eligibility/selection criteria at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/rejected for the said post.
- m. Candidates will not be paid any TA/DA for document verification.
- n. Project Director, PSACS, reserves the **right to cancel/modify** the entire recruitment process at any stage without issuing any further notice.
