Educational Qualifications :

Candidates, for the post of **Stenographers Grade-III and Clerks**, should have possess a degree of Bachelor of Arts or Science or equivalent thereto from a recognized University. He/she should have passed matriculation examination with Hindi as one of the subject and must have proficiency in operation of Computers.

<u>Age</u> :

The minimum age limit of a candidate for appointment to the aforesaid posts shall be 18 years and the upper age limit shall be in accordance with the latest instructions of the Haryana Government in this regard to be calculated as on 01.01.2024.

In the case of candidates belonging to Scheduled Caste and Backward Class-A and B of Haryana State and persons already in Government employment, the upper age limit shall be such as may be fixed by the Haryana Government from time to time.

Mode of Selection for the post of Stenographer Grade-III

Candidates for the post of Stenographers Grade-III will have to qualify the English Shorthand Test and its Transcription at the speed of 80 w.p.m. and 20 w.p.m. respectively on Computer. The candidates will also have to qualify a Computer Proficiency Test. The prescribed Stenography test shall be held on 05.02.2024. The candidates shall report for the test sharp at 9:30 AM. The candidates shall bring their own shorthand note book and pencil.

Place of examination/Test

The place of the examination will be informed on the website https://hisar.dcourts.gov.in/notice-category/recruitments/ No separate letter will be issued. It shall be the responsibility of the candidates to keep themselves updated about the same.

Mode of Selection for the post of Clerk

The selection for the post of Clerks will be made on the basis of a written examination in the subjects of (i) English Composition and (ii) General Knowledge consisting of 50 marks each. No candidate shall be considered for appointment unless he/she obtains 40% marks in agreegate (33% qualifying marks in each subject) in the written examination. The candidates who would qualify the prescribed written test shall be called for Computer Proficiency Test. The candidates will have to qualify Computer Typing Test in English at the speed of **30 w.p.m.** The written test for the post of Clerk shall be held on 03.02.2024. The candidates shall report for the test sharp at 9:30 AM.

Place of examination/Test

The place of the examination will be informed on the website https://hisar.dcourts.gov.in/notice-category/recruitments/ No separate letter will be issued. It shall be the responsibility of the candidates to keep themselves updated about the same.

The selection for the aforesaid posts shall be made strictly in accordance with the provisions of Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service) Rules, 1997.
