**ADVERTISEMENT FOR FILLING UP OF POSTS OF JUNIOR RESIDENTS ON CONTRACTUAL  
BASIS IN SLNMCH, KORAPUT**

Eligible candidates are invited for Walk-in-Interview for selection to the post of Junior Resident in SLNMCH, Koraput on contractual basis. The applicant must have acquired the required qualification for the post applied for, on or before the date of counselling. The engagement shall be purely temporary for a period of one year which may be extended on year-to-year basis. The posts are non-practicing. The candidates will be paid consolidated amount of **Rs.60,000/-** (Rupees Sixty Thousand) only per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Eligibility of application will be guided as per the provisions mentioned here under:

1. Available vacancy : 32

2. Age : Must be less than 70 years.

4. Eligibility and Qualification for Junior Residents

a. Qualification:

- i. A candidate must possess a MBBS degree (for Medical stream) recognized by MCI/NMC/as the case may be.
- ii. The candidate must have completed the compulsory one-year rotating internship
- iii. The above qualifications must have been obtained on or before the date of counselling.

b. Other Eligibility Conditions:

- i. The candidate must be a citizen of India.
- ii. The candidates must have registered their Medical Qualification at Central/ State Medical Council. (Permanent Registration)
- iii. Candidates having post-graduation in any discipline or are continuing or have completed three years tenure as Senior Resident/ Tutor in any MCI/ NMC permitted/ approved/ recognized institute are not eligible to apply.
- iv. Candidate who are serving under OMHS cadre on regular basis are not eligible to apply.

## 5. Procedure of Interview:


Candidate shall download the Application Form annexed in this Advertisement (Page 4 & 5) from SLNMCH website Or District website and come for the Interview with duly filled in **Application Form and all requisite original documents.**

- I. The candidate shall have to appear personally before the convenor on **20.01.2024 at 10:30 am** in the office of Dean & Principal, SLNMCH, Koraput alongwith the following documents:
  - a) Application form duly filled in
  - b) One passport size recent color photograph signed by the candidate at front to be pasted on the application form.
  - c) All Original Documents
  - d) Self attested photocopies of:
    - H.S.C./ Equivalent certificate in support of age
    - +2/Equivalent examination certificate
    - MBBS pass certificate
    - Mark sheet in support of all the aforesaid examination (i.e. from H.S.C onwards) passed including fail marks.
    - Chance certificate of MBBS
    - Internship Completion Certificate
    - Certificate of Medical Registration (up to date)
    - Valid Photo ID issued by the Govt. authorities i.e Passport/ PAN Card/ Voter ID card/ Aadhar Card)
- II. At the time of documents verification, physical presence of the candidate is mandatory and no authorization will be entertained.

**N.B:** In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/ her application shall be rejected and disciplinary/ legal action as deemed proper will be initiated against him/her.

## 6. Selection Process:

- a) After successful verification of the documents, a Provisional Merit list shall be prepared on the basis of career marks and notified in the official website of SLNMCH, Koraput.
- b) The grievances from the candidates, if any, will be allowed to be put forth to the official [Email-slnmchkoraput.od@gov.in](mailto:Email-slnmchkoraput.od@gov.in).
- c) The grievances if any will be examined and a final merit list will be notified in the official website of Koraput District as well as SLNMCH website. The final list will remain valid for a period of one year or till subsequent advertisement whichever is earlier.
- d) The appointment/ engagement order shall be uploaded in the website of SLNMCH i.e. <https://slnmch.nic.in/>.
- e) The candidate must report before the authority within 7 days of issue of appointment order.
- f) In case, the candidate appointed to a post, fails to join in time, the next candidate in the panel may be given a chance.

**7. Selection Process:**

- a) Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
  - HSC/ Matriculation-20% of total percentage of marks secured.
  - Intermediate Science-20% of total percentage of marks secured.
  - MBBS examination-60% of total percentage of marks secured.
- b) One mark will be deducted from the total Career mark for each extra attempt taken to pass the examination.
- c) In case of Foreign Medical Graduates (FMG) the marks secured in the subject as per the NMC/ MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such a marksheet, their marks will be taken as 50%.
- d) In case of tie, it will be resolved as follows:
  - i. The candidate securing more mark in MBBS shall be placed in higher rank.
  - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.

**8. Terms and Conditions:**

The terms and conditions as stipulate in the Govt. guidelines issued from time to time in force will be followed.
