### 1. Junior Research Engineer (Consolidated Salary Basis):

#### Essential Qualification & Experience:

B. Tech./B. E or M. Sc. in relevant discipline with minimum 55% marks and one year of relevant experience in lab experiments and in reputed laboratories.

#### Desirable:

1. Hands on experience in wet lab experiments and has worked in reputed laboratories
2. Preference will be given to M. Tech. or Ph.D. degree holders in relevant discipline

#### Key Responsibilities (indicative):

1. Maintain and upkeep of teaching laboratories;
2. Assistance in teaching activities in the lab courses;
3. Assistance in research projects;
4. Assistance in the procurement of laboratory resources;
5. Assist faculties in evaluating the students related to laboratory work;
6. Assisting and facilitating students in executing their laboratory work

#### Compensation and Appointment Terms:

- JRE will be appointed on contract and consolidated salary basis for one year, which can be extended based on performance.
- Maximum term of appointment is two years. No extension will be given after two years.
- The monthly compensation will be Rs 50,000/- per month.
- The Institute gives top priority to the ongoing academic activities and does not promote leaving the offered position during an ongoing semester. To ensure this, a monthly deposit of Rs.27,500/- from the salary of the first two months will be kept with the institute. This deposit will be paid on completion of the offered tenure.

### **General Information/ Conditions/ Instructions:**

1. Shortlisted candidates will be informed for written test/ interviews through registered e-mail only.
2. The Institute reserves the right to restrict the number of candidates for written test/interview to a reasonable limit, on the basis of desirable qualification and experience.
3. The Institute also reserves the right of rejecting any or all the applications without assigning any reasons thereof.
4. Eligibility of a candidate to the post will not automatically mean that he/she will be shortlisted and called for further selection process. No request in this regard will be entertained for review etc.
5. Qualifications/experience, age may be relaxed for exceptional candidates.
6. Number of positions may be increased or decreased depending upon the requirements.
7. The selected candidates will be expected to join within one month from the offer of appointment.
8. This appointment can be terminated by giving one-month notice or salary in lieu of notice period by either side following the no-dues process.
