#### Conditions

- a) It is the responsibility of the candidate to submit the application and to attend the interview in person/online on scheduled date and time as communicated by email/text message.

The University (MPKV) or this project holds no responsibility for regularization/appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporary; time-bound arrangement on contractual and co-terminus basis with the project.
- 3. If any Young Professional- II leaves his/her assignment without permission for one month, he/she will stand terminated from the date of his/her absence.
- 4. The appointment of Young Professional- II will be terminated at any time by the issue of 24 hours' notice if they found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct or of discipline.

- 7. Young Professional- II will have to work anywhere in the jurisdiction of MPKV as and when the need arises.
