Applications are invited from eligible candidates for the following position for the Pan India Study entitled “**Diet and Biomarker Survey in India (DABS-I)**” funded by ICMR at this Institute on temporary contract basis in **Meghalaya**. These posts require an extensive travel in the state of **Meghalaya** to co-ordinate the study.

The **Walk-in-interview** will be conducted on **24th April, 2024** at Office of The District Medical & Health Officer, Lower Babupara, Tura, Meghalaya, Pin: 794001 . Applications will be received from the individuals by hand on the date of Walk-in-interview between **9:30 am to 10:30 am**. The Candidates may download the application form from www.nin.res.in and submit the same duly filled in along with one set of photocopies of certificates and one latest photograph and all the Original Certificates for verification failing which their candidature cannot be considered for Interview.

After verification of the applications, the names of eligible candidates will be informed on the same day for Walk-in-interview. The candidates have to make their own arrangements for attending the Walk-in-Interview. The applicants are advised to visit our website ww.nin.res.in regularly for any updates and changes in the recruitment process.

Terms & Conditions:

1) The number of posts may vary according to the project requirement and the above posts are on temporary basis only.

2) Age relaxation will be as per GOI/ICMR guidelines.

3) Upper age limit is relaxable up to 5 years in case of candidates belonging to SC/ST and 3 years in case of OBC category as per DoPT rules. The candidates should ensure that they belong to the OBC category while applying the project posts. Such candidates should produce a valid OBC-Non Creamy Layer certificate in the prescribed format during document verification that he/she does not belong to the creamy layer. The OBC certificate shall not be older than one year at the time of joining the post. In case of not complying with these stipulations, their candidature or OBC reservation will not be entertained.

4) The Director & Appointing Authority has the right to accept/reject any application without assigning any reason(s) and no correspondence in this matter will be entertained.

5) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project.

6) Presently serving or previously served ICMR-Project employees who have completed three years of project service are not eligible to appear for walk-in-interview. The maximum term of any Project Position in any or multiple projects, with breaks or without breaks shall be three years only.

7) The results of the final selection will be placed on ICMR-NIN and ICMR websites. No intimation will be sent by e-mail or phone.

8) The recruited project staff is eligible for leave as per project recruitment rules/guidelines and will have to give an undertaking before joining.

9) At the time of joining duty, the candidates should bring all original certificates of educational qualifications (from SSC onwards), No Objection Certificate from present employer (compulsory), Experience, Aadhaar Card, Community and PWD Certificate (if applicable) for availing age relaxation, passport size photograph along with one set of photocopies of the certificates duly attested (can be self attested) for verification.

10) Canvassing in any form will lead to disqualification.
