



**Engagement of Teaching Assistants purely on Adhoc basis in

The Sardar Vallabhbhai National Institute of Technology Surat invites applications for engagement of Teaching Assistants purely on ad-hoc basis for 11 Months. The details regarding eligibility criteria, terms of references etc. are as follows:

Educational and other qualifications, experience and Specializations required for recruitment <u>Essential Qualification:</u> (i) First Class or an equivalent CGPA (Min 6.5 on the scale of 10) in M.Tech/M.E. and 1st Class or an equivalent CGPA (Min 6.5 on the scale of 10) in B.Tech/B.E. with Good Academic Record. <p style="text-align: center;">OR</p> (ii) Ph. D. (in appropriate branch) with first Class or an equivalent CGPA (Min 6.5 on the scale of 10) in B.Tech/B.E. and 1st Class or an equivalent CGPA (Min 6.5 on the scale of 10) in M.Tech /M.E. with Good Academic Record. <u>Specializations:</u> The Teaching Assistant should specifically possess necessary specializations in relevant areas of Artificial Intelligence such as Machine Learning, Deep Learning, Image Processing and Computer Vision, Natural Language Processing, Cloud Computing, Big Data Analytics, Internet of Things, Information Retrieval, Robotics, Intelligent Multiagent and Expert System, Data Science, Swarm Intelligence, High Performance Computing, Cyber Physical System, Soft Computing and fundamental subjects of computer science.	
8.	<u>Application Process:</u> The eligible interested candidates have to download the application form and submit the hard copy of their filled in applications through Speed/ Registered Post in prescribed format with duly attested copies of all certificates & Mark-sheets, to The Head of Department, Department of Artificial Intelligence, Sardar Vallabhbhai National Institute of Technology, Surat, Ichchhanath, Dumas Road, Keval Chowk, Surat, Gujarat-395007 so as to reach on or before 22nd April 2024 . The envelope should superscribed as Application for the Post of Teaching Assistant (Department of Artificial Intelligence) on Purely Adhoc Basis (Last Date 22nd April 2024).	
9.	<u>Selection Process:</u> The shortlisted candidates will be called for written test / interview. The final selection will be based on the performance of candidate during personal interview at SVNIT Surat.	

Mere fulfilling minimum qualification and experience will not vest any right in candidate for being called for written Exam and / or interview. The shortlisting parameters will be decided by the Institute and thereafter, adequate number of candidates, as decided by the Institute, will be shortlisted for interview. The decision of the Institute Authorities shall be final. No correspondence will be entertained in this regard.

10. **General Instructions & Other Information:**

- i. The engagement would be purely on Adhoc basis. **Any** claim for absorption at the regular position in the institute will not be entertained at any point of time.
- ii. The engagement will be subject to their medical fitness and police verification.
- iii. The Institute reserve the right to terminate the services of the appointee at any by giving one-month notice or payment of one-month salary in lieu thereof by either side without assigning any reason.
- iv. The appointee will not be entitled for any medical facility/ accommodation or any other type of allowances.
- v. The appointees have to attend the office six days a week.
- vi. In case of exigencies of the work, the appointee shall be required to attend the duty on Holidays. No extra remuneration shall be admissible for the same.
- vii. The Headquarters of the appointee shall be at Surat.
- viii. The Institute reserves the right to impose any other reasonable conditions to safeguard the interest of the Institute.
- ix. Any resultant dispute shall be settled within the jurisdiction of Surat.
- x. The closing date for submission of applications shall be considered as the cut-off date of age, educational qualifications and experience.
- xi. In case of CGPA/GPA, the applicants are required to enclose the appropriate conversion formula to percentage / CGPA/GPA calculator. In case CGPA conversion table is not available from their graduating institutions, the criteria applicable for SVNIT, Surat will be used for % conversion.
- xii. All pages of the hard copy of the application must be numbered and signed by the applicant. The total number of pages in the application form must be written on the first page of the application form. All the supporting documents must also be self-attested.**
- xiii. It will be the responsibility of the candidate to provide reliable and independently verifiable documentary evidences along with the application form to support all the information and credentials claimed in the application form.
- xiv. The date for determining the eligibility of candidates in every respect, i.e., qualification, experience, preferred age limit, etc., shall be considered the closing date of the respective round of rolling advertisement online application.
- xv. The Institute reserves the right to assign / transfer the selected candidates to any section/ department within the Institute.
- xvi. No TA/DA shall be admissible for appearing in the written test/ Interview/ joining at SVNIT, Surat.
